## Membership Qualifications and Types:

<u>Active Member</u>- Shall consist of persons actively engaged in the science of forensic identification and their bureau department heads. Active Members shall not lose their status because of retirement or change of position, so long as they remain in good standing. Active Members may hold office within the Division.

**Associate Member**- Shall consist of all reputable persons. wholly or partially engaged in any of the various phases of the science of identification, and who are not qualified for Active membership, are hereby eligible to become Associate Members. They shall, in all respects, be subject to the same rules, fees and charges, and entitled to the same rights and privileges as Active Members, except that they shall not be entitled to election to any office or be members of the Board of Directors.

**Student Member-** Shall consist of all reputable persons, fully or partially enrolled as a student pursuing a degree with a concentration in forensic science or criminal justice, who are not qualified for active or associate membership, are hereby eligible to become Student members. They shall, in all respects, be subject to the same rules, rights and privileges as Associate Members, including the ability to serve on committees within the organization; with the exception they shall not be able to sit as Chair of any committees nor be entitled to election of any office or to be a member of the Board of Directors.
