I had also asked Julie H to draw up a laundry list of tasks the QEP and IE offices needed GEC to address this year. [Included in this handout was a summary of a decision made at an August 18 work session (see attendance, p. 1) regarding labeling of GEC requirements in PeopleSoft. She handed this out, and we discussed those items too. Pages 2-4 of this handout listed and elaborated on 4 pressing issues QEP and IE need GEC to address: (see items 1-4, top of p. 2 for this priority list).

The GEC agreed to (1) start with reviewing and revising the GEC narrative in the Bulletin (including the 36 learning outcomes), and (2) undertake a review of GEC learning outcomes, *starting with the capstone courses* (and Julie H agreed to provide us with a list of items such a review would need to address).

A concern was voiced in the committee that some program administrators responsible for GEC 06, 07 08, 09 may be assigning these important courses to adjunct instructors. Bill Powell agreed to collect data for us on who is teaching these courses.

Kathryn L and Julie H shared information about conferences and other resources that would be helpful to the GEC committee for dealing with GEC issues successfully.

**A comment by Julie H** regarding the learning outcomes: Revising the wording of the 36 outcomes will be a large task. I would recommend looking at the speaking outcome as it was initially not included at all, then inserted with the writing, then separated because it was being ignored. There are specifics in the GEC narrative regarding the speaking components that should be included (audience analysis, etc.) that might be useful to include in the outcome.

## General Education Committee Report: Progress towards the Revision of the GEC Narrative

In response to the many questions that the Office of Institutional Effectiveness receives about the General Education Curriculum (GEC) narrative, our committee is in the process of revising it. The following is a statement of the rationale that will guide us through the revision process. Since our work is ongoing, the committee members welcome feedback on this rationale from other members of the Academic Council along with suggestions of other issues that we should address.

- 1. Our main premise is that the GEC narrative embodies the thought and work of many faculty and should not be altered without good reasons.
- 2. The GEC narrative document is not linear, in that people rarely read it all the way through from start to finish. Therefore, its organization should facilitate locating specific elements of the narrative.
  - a. This may involve beginning with an over-arching summary of the GEC and including references to where more detail on specific parts of the narrative can be found (a type of linking of information).
  - b. Another aspect of this revision will be to consider establishing more consistency between the current degree plan template and the GEC narrative.
- 3. The wording of specific requirements should reflect actual practice (for example, do not state that courses must assign essays to fulfill the written competency requirement if other types of writing assignments are acceptable). This is especially the case in requirements linked to assessing how programs are complying with the GEC.
- 4. Terminology should be clearly defined to prevent ambiguities in how to interpret the narrative.
- 5. To facilitate locating the GEC narrative, move it out of the Student Life section of the Bulletin and into the Academics section.

#### Report to Academic Council From the Academic Standards committee Report compiled by Daniel Capper, committee chair October 31, 2008

#### Issue #1:

We have been charged by Academic Council to find standards for the acceptance or non-acceptance of GEC courses in minisessions. The Academic Standards committee proposes the following criteria:

To approve a GEC course (GEC 01-09) for offering in a minisession term, Academic Council requires:

- 1) a description of course GEC student learning outcomes and a detailed description of course activities for all minisession course proposals. This includes a syllabus for the course as taught in regular semesters, if one is available.
- 2) that in-class activities be appropriate for achieving stated GEC student learning outcomes.
- 3) that course readings and similar assignments be appropriate for achieving stated course GEC student learning outcomes.
- 4) that graded assignments be appropriate for achieving stated course GEC student learning outcomes.
- 5) that if the course is taught in regular semesters, the minisession version of the course must be substantially similar to the version of the course as taught in a regular semester.
- 6) that after a GEC course has been taught in the minisession three times, findings relevant to achieving GEC student learning outcomes from minisession sections must be compared to findings derived from regular session sections of the course. Should the minisession version of the course fail to compare favorably to the regular session version in terms of these findings, Academic Council retains the right to rescind course approval for the minisession version of the course.

#### Issue #2:

We have been charged with determining whether syllabi should be required for the acceptance of new courses. Currently the policy on course acceptance reads as follows:

"A detailed syllabus or list of daily assignments is not required, although the majority of requirements listed above probably would appear in a syllabus. Normally, documentation for a proposal can be encompassed within two pages of text."

We propose changing the policy to read as follows:

"A detailed syllabus including assignments is required."

#### Issue #3:

Dr. Stephen Judd has claimed that it is university policy to require a 2.0 GPA of students to change majors. He would like this policy to be changed, as he feels it creates a catch-22 for students, as students get stuck try to raise their GPA's in majors where they already underperform.

However, we have been unable to find any evidence of such an official university policy. We think this policy has just been an informal tradition. But members of our committee seem to think that it is not a good idea, whether it is an official policy or not. A sticking point here is that some programs prefer to be selective in their acceptance of majors. So we offer the following statement on the issue:

The University of Southern Mississippi will not require students to have a 2.0 grade point average in order to change majors. Individual departments, however, are free to create their own standards regarding grade point averages and changes of majors. Should such policies prevent a student from declaring a major, that student can elect to change to General Studies until they academically are in a position to declare a major.

Report to Academic Council From the Academic Standards committee Report compiled by Daniel Capper, committee chair November 20, 2008

### Issue #1:

We have been charged by Academic Council to find standards for the acceptance or non-acceptance of GEC courses taught in non-traditional schedules. Such non-traditional courses include courses taught mini-sessions, five week summer sessions, three week sessions, and weekends-only sessions. The Academic Standards committee proposes the following criteria for acceptance of these courses:

To approve a GEC course (GEC 01-09) for offering in a non-traditional term, Academic Council requires: 1) a description of course GEC student learning outcomes and a detailed description of course activities for all non-traditional course proposals. This includes a syllabus for the course as taught in regular semesters, if one is available.

- 2) that in-class activities be appropriate for achieving stated GEC student learning outcomes.
- 3) that course readings and similar assignments be appropriate for achieving stated course GEC student learning outcomes.
- 4) that graded assignments be appropriate for achieving stated course GEC student learning outcomes.
- 5) that if the course is taught in regular semesters, the non-traditional version of the course must be substantially similar to the version of the course as taught in a regular semester.
- 6) that after a GEC course has been taught in the non-traditional three times, findings relevant to achieving GEC student learning outcomes from non-traditional sections must be compared to findings derived from regular session sections of the course. Should the non-traditional version of the course fail to compare favorably to the regular session version in terms of these findings, Academic Council retains the right to rescind course approval for the non-traditional version of the course.

## Issue #2:

We have been charged with determining a policy regarding requiring library impact statements for all new course proposals. We need information from Carole Kiehl, Dean of Libraries, to gain information towards a better understanding of this issue. Unfortunately Dean Kiehl suffered a major death in her family recently. Therefore we will return to this issue at a later date.

# THE UNIVERSITY OF SOUTHERN MISSISSIPPI General Education Curriculum 2009-2010

**General Education Mission:** The General Education Curriculum (GEC) of The University of Southern Mississippi is designed to equip its graduates with a broad range of knowledge and skills and the wisdom to deploy them appropriately. In order to build lives of dignity and purpose, University graduates in the twenty-first century will need to

- analyze and evaluate private, public and professional discourse
- assume leadership roles, making use of effective oral and written communication
- engage their local, national and global communities as responsible citizens
- integrate knowledge across subject matters and disciplines
- approach problems with enthusiasm, energized by a spirit of inquiry
- adapt to professional, technological and social change with flexibility and resourcefulness
- make choices, conscious of intellectual, social, and ethical contexts
- see themselves, their communities and their nation in historical context
- assess scientific data and conclusions
- appreciate the arts and their contribution to enlarging the human spirit, and
- collaborate with others to create a humane world

The faculty and administration of The University of Southern Mississippi are committed to providing educational experiences that empower our students not only to meet these challenges, but also to engage the future using the habits of learning acquired during their University education.

## **General Education Curriculum Oversight**

The University of Southern Mississippi Academic Council provides general supervision over the undergraduate academic affairs of the University including the General Education Curriculum. The General Education Committee of the Academic Council is responsible for reviewing and recommending to the Academic Council all courses proposed for inclusion in the University's undergraduate General Education Curriculum. The Committee is also responsible for monitoring the effectiveness of all courses included in the General Education Curriculum according to the policy, procedures, and criteria specified in the Academic Council Bylaws. The Office of Institutional Effectiveness provides administrative support to the Academic Council.

General Education Curriculum Student Learning Outcomes: The General Education Curriculum is structured for students to attain specific learning outcomes organized around five broad principles.

## Essential Skills

- 1a. Students will demonstrate the ability to develop and focus on one topic in writing assignments and present ideas in an organized, logical and coherent form.
- 1b. Students will demonstrate the ability to develop and focus on one topic in speaking assignments and present ideas in an organized, logical and coherent form.
- 1c. Students will demonstrate the ability to use Standard English grammar, punctuation, spelling and usage.
- 2a. Students shall model real-world situations with linear, quadratic, exponential or logarithmic functions and solve equations related to these situations.
- 2b. Students will demonstrate fundamental math skills.
- 2c. Students will demonstrate skill in electronic collaboration.
- 2d. Students will demonstrate the ability to create structured electronic documents.
- 2e. Students will demonstrate the ability to do online research and evaluation.
- 2f. Students will demonstrate competency in the operation of a computer.

## Acquisition and Integration of Knowledge

- 3a. Students will have a good understanding of the scientific method.
- 3b. Students will have good knowledge of the basic concepts of at least one science discipline.
- 3c. Students will have a good understanding of the current areas of concerns or emphasis within at least one science discipline.
- 3d. Students will be able to interpret scientific data and reach a plausible conclusion.
- 3e. Students will have a good understanding of the techniques used in science.
- 4a. Students will demonstrate a basic awareness of current issues and concerns.

- 4b. Students will demonstrate an understanding of the manner societies address or develop solutions to current issues and concerns.
- 5a. Students will demonstrate an understanding of the development of at least one society.
- 5b. Students will demonstrate an understanding of the interrelationships between societies.
- 6a. Students will demonstrate an understanding that social institutions, such as the family, religion, education and formal organizations are closely related to each other and are evidence of the integration of our complex global social systems.
- 6b. Students will demonstrate an understanding that governments and economics are closely related to each other and are evidence of the integration of our complex global social system.
- 7a. Students will demonstrate the ability to connect ideas in a coherent essay.
- 7b. Students will demonstrate the ability to connect course content to other disciplines and/or to real world situations.

### Aesthetic Understanding

- 8a. Students will demonstrate an understanding of the influence of art, music, literature, theatre or dance on culture.
- 8b. Students will demonstrate an appreciation for art, music, literature, theatre, and/or dance.

## Development of Logical and Critical Thinking

- 9a. Students will demonstrate the ability to write an analytical essay.
- 9b. Students will demonstrate the ability to find and use (and cite) relevant sources.
- 9c. Students will be able to analyze the components of an argument.

## Responsibility, Self and Society

10a. Students will demonstrate an understanding of at least one historical and one contemporary theory of human behavior and their application to "real world" problems.

10b. Students will demonstrate an understanding of ethical behavior in social contexts throughout the understanding and application of academic honesty and the ethical codes and guidelines relevant to two or more disciplines.

11a. Students will demonstrate an understanding of at least two theories of morality or moral development, and their application to "real world" situations.

11b. Students will demonstrate an understanding of at least two theories of group or social processes, and the role they play in ethics, morality or justice.

- 12a. Students will explain implications of diversity among individuals.
- 12b. Students will be able to explain the implications of familial, sexual or religious diversity among individuals.
- 13a. Students will be able to explain the implications of political diversity within or among social systems.
- 13b. Students will be able to explain the implications of familial, sexual or religious diversity within or among social systems.
- 14a. Students will be able to discuss (in speaking or writing) major developments in world history.
- 14b. Students will demonstrate knowledge of the literary and creative contributions of world cultures.

#### **General Education Curriculum Student Learning Outcome Assessment**

All GEC courses are required to be assessed based on the GEC student learning outcomes. An annual GEC assessment report must be submitted by the academic unit. Additionally, selected students may participate in the administration of a national, standardized General Education Assessment Exam.

## Writing and Speaking in the General Education Curriculum

Fluency in communication is the hallmark of an educated person. Therefore, the General Education Curriculum emphasizes the development of college-level communication skills of all students.

Writing. Courses in the first five GEC categories, with the exception of Mathematics, require students to write a minimum of 2500 words. In addition, English 102 requires students to write at least 5000 words. Each degree plan specifies: (1) an upper-level course that is writing intensive and (2) a Capstone. In each of these courses, students are required to write a minimum of 5000 words.

Speaking. Each degree plan specifies: (1) an Oral Communication course and (2) a Capstone. At least one of these courses requires the successful completion of a minimum of two graded speeches. The other course may substitute two appropriate graded oral communication equivalents.

Writing and Speaking Resources for Students and Faculty. The University of Southern Mississippi is committed to providing a learning environment that offers enhanced support for strengthening speaking and writing skills. Students have access to individualized assistance with writing and speaking assignments for any course through the University's Writing Center and Speaking Center on both the Hattiesburg and Gulf Coast campuses. The centers offer free, personalized assistance at any stage of the process with the goal of helping students become more effective writers and speakers. The Speaking Center also includes a presentation rehearsal studio with the tools and space to rehearse, record, and view a presentation. Faculty members have the opportunity to participate in a faculty development seminar designed to enhance student learning outcomes in oral and written communication across the curriculum. Faculty resources for incorporating writing and speaking assignments are also available through the centers.

## General Education Curriculum Syllabi

Syllabi of courses in the General Education Curriculum must include a statement or description of: (a) GEC Student Learning Outcomes addressed in the course; (b) course content and related activities; (c) student reading and writing requirements, where appropriate; (d) instructional methods and resources; and (e) student performance standards (including rubric if applicable).

#### Final Exams or Projects in the General Education Curriculum

All courses in the first five General Education Curriculum categories require a significant final project or proctored final examination.

## **GEC 06. Computer Competency Requirement**

Each degree plan specifies a GEC Computer Competency course or exam.

## GEC 07. Writing-Intensive Requirement (Prerequisite: ENG 101 and ENG 102)

Each degree plan specifies an upper-level GEC Writing-Intensive course. Departments may elect to develop a program-specific writing-intensive course within major courses or have students take an appropriate writing-intensive course in another department. GEC writing-intensive courses are defined as those that, while focusing on a specific subject matter (with corresponding readings and discussions), encourage students to think critically and creatively, outline a subject matter or theme, and produce drafts. In writing-intensive courses, students write a minimum of 5,000 words (approximately 20 pages of double-spaced typed text) in discipline-specific papers and assignments. Class enrollment is capped at 24.

## **GEC 08. Oral Communication Requirement**

Each degree plan specifies a GEC Oral Communication course. Departments may elect to develop a program-specific oral communication course within major courses or have students take an appropriate oral communication course in another department. GEC oral communication courses are defined as those that require students to earn satisfactory grades for two or more oral presentations or equivalents. The oral communication components of these courses should teach rhetorical reasoning, audience adaptation, professionalism, and presentation skills including clarity of expression, ideas and voice, as well as prepare students to be critical consumers of public discourse.

## **GEC 09.** Capstone Requirement

Each degree plan identifies a program-specific communication-intensive GEC Capstone. The Capstone must be taken the senior year and must meet the written and oral communication requirements outlined below. The program utilizes the Capstone as a means of assessing student achievement of the program's student learning outcomes. To receive credit for the Capstone, students must receive a grade of C or better. Class enrollment is capped at 24.

## Capstone written and oral communication requirements:

The writing component of the Capstone requires students to write a minimum of 5,000 words (approximately 20 pages of double-spaced typed text) in discipline-specific papers and assignments. The written communication component should teach students to focus on a specific subject matter (with corresponding readings and discussions), encourage students to think critically and creatively, outline a subject matter or theme, and produce drafts.

The oral communication component of the Capstone requires the successful completion of a minimum of two graded speeches or two appropriate graded oral communication equivalents. The oral communication component should teach rhetorical reasoning, audience adaptation, professionalism and presentation skills including clarity of expression, ideas and voice, as well as prepare students to be critical consumers of public discourse.

## **Alternative Credit for the General Education Curriculum**

A student may receive credits for a GEC course if he or she is able to demonstrate mastery of the course material. Credit can be received for any GEC course in one of the following three ways: the student 1) completes an equivalent course with an acceptable score through the College Entrance Examinations Board's Advanced Placement Testing Program before entering The University of Southern Mississippi; 2) passes an appropriate CLEP examination or 3) passes a departmental challenge examination on the relevant course material. The detailed procedures and regulations regarding these three methods of obtaining up to 30 hours credit toward a degree at The University of Southern Mississippi are described in the General Academic Information section of this *Bulletin*.

Additional requests for exemptions and substitutions for the requirements of the General Education Curriculum should be addressed to the Provost.

## Individual student requests are handled in the following manner:

- 1. The student's department (advisor, then chair/director) sign and then forward the request to the dean of their major.
- 2. The major dean then forwards the request to the accepting department.
- 3. The accepting department forwards the request to the dean of the accepting major.
- 4. The request is then forwarded to the Provost.

# Choice of Bulletin (approved 2-9-2009)

## Current (p. 74)

Graduation requirements must be met under a bulletin that is not more than six years old at the time of the student's graduation (exclude the current year's bulletin in counting the six) and that carries announcements for a year during which the student earned some credit at The University of Southern Mississippi or another accredited institution of higher learning, including community and junior colleges.

## **Proposed**

Graduation requirements for any degree program must be met under a bulletin of the student's choice that is not more than six years old at the time of the student's graduation (exclude the current year's bulletin in counting the six) and that carries announcements for a year during which the student earned some credit at The University of Southern Mississippi or another accredited institution of higher learning, including community and junior colleges. When students are pursuing a degree that leads to external licensure, the student must meet the licensure requirements regardless of *Bulletin* year selected.

# Program Review Committee Executive Report Political Science, International Development and International Affairs

Stanley Hauer, Program Review Committee member (reviewer)
Douglas Masterson, Program Review Committee Chair (executive report)

The Political Science Department conducted a self-study using the external review process. The external review reports were checked by the Program Review Committee of Academic council. The external reviewers (Professors Livingston and Jilson) report describes a department with good future prospects and identifies obstacles needing to be addressed. The self-study documents were short on data and the Graduate Council reviewer commented on the need for a "more positive" approach to the self-study. Some examples of the "negatives" in the self-study document include:

- The assessment plan-noted as only marginal by both councils-has no current effort to improve it (5.2).
- There are no plans at present for the establishment of an external advisory board(9.1)
- External funding is not at an appropriate level (10.2).
- Technology transfer is not applicable to the department (10.3).
- There exists no departmental program for faculty development (10.4).
- The department has no formal governance document (11.1).
- Collaboration across disciplines is "not...a priority" (11.3.1.3).

The following are excerpts from the external review report from their visit in May 2008: (Professor Livingston-Middle Tennessee State University, Professor Jilson-SMU)

The external reviewers note the problems for the department of the dual campus-system. "Though there is no lack of willingness..., miscommunication and inadequate preparation are rife." They also report problems in the undue burden of administration borne by junior faculty. (it should be noted that since this study was published in April 2008 the department hired a competent and experienced department chair, a move expected to alleviate of the governance issues in the PSIDIA unit.) They also acknowledge the tentative nature of the union of disparate disciplines (especially on the graduate level) in a traditionally political science department. Their sharpest criticism concerns the curriculum, notably a lack of broad, international polity and the absence of a course in race and politics. The lack of a structured program supporting student internships is also a noted weakness. The department has at present a "skewed focus", they fell, with too many undergraduates in the paralegal program and too few students in the traditional political science discipline. The budget is "insufficient" and teaching loads are "heavy". The reviewers note that the department's prospects are good: "There are some obstacles to this future, but given some tough decisions and the necessary resources, there is also great promise."

The Academic and Graduate Councils both note a lack of specificity and data in the documentation. The AC regrets that goals are not specified and that objectives are not "overtly aligned" with those of the college and university.

The following is a summary of the departmental response:

The department frets over the lack of a 100-level introductory course, feeling that the peculiar placement of its lower level course in the GEC is largely to blame for declining number of majors. The need for a course on race and politics might be solved by colluding with the new program in black studies; however the reviewers' demand for a wider international scope "can only be solved with a new hire." The department agrees to address the problem of internships by creating a new course and designating a faculty member to take responsibility for this important issue.

The following is a summary of the response from Dean Von Herrmann:

A political scientist herself, the dean differs sharply with her colleagues in certain regards during the course of her response. Not surprisingly, this difference in opinion is most notable in budgeting: "I do not believe the department is in a serious need of either new faculty or other substantial new resources", writes Dean Von Herrmann. She finds evidence that the self-study was "hastily prepared" but acknowledges the department's growing pains with its recent additions of new programs. Dean Von Herrmann believes "the department's problems appear to be relatively simple to overcome, if the department is willing to put aside past issues or concerns and move forward in a positive direction." The dean pledges her time and full commitment to lead the department in achieving its new goals.

# Special note on paralegal studies:

The PLS program is accredited separately by the American bar Association. PLS prepares a separate self-study and undergoes a different process. The self-study was written twice, once for a visit that failed to occur in 2007 and then a year later for a visit in February 2008. Professors Gibbs (Avila University) and Schoebel (Capital University Law School) prepared an extensive response, recommending reapproval of the program's national accreditation. However, they did make recommendations which include a separate budget for PLS, improved coordination between the campuses, greater racial diversity in faculty, more support for the program director, further professional development of faculty. The reviewers also note the need for training students and faculty in "Westlaw", a program widely used throughout the legal profession.

# **Second Baccalaureate Degree**

Current: Based on 128-hour minimum (p. 76)

Students who have earned a baccalaureate degree may be granted by The University of Southern Mississippi a second baccalaureate degree based upon requirements of an applicable bulletin, provided the program for the second degree includes at least 32 semester hours in residence with at least 64 quality points (equivalent to a 2.0 average on a 4.0 scale). The actual number of hours to be taken, which may exceed 32 as well as the specific degree requirements, will be established by the academic department responsible for the area of study in which the second baccalaureate is sought. In all cases, a 2.0 grade point average is required. The 32 semester hours must be related to a specific major separate from the first major, and the 32 semester hours must be completed after the first degree has been conferred.

## Proposed:

Students who have earned a baccalaureate degree may be granted by The University of Southern Mississippi a second baccalaureate degree based upon requirements of an applicable bulletin, provided the program for the second degree includes at least 30 semester hours in residence. The actual number of hours to be taken, which may exceed 30, as well as the specific degree requirements, will be established by the academic department responsible for the area of study in which the second baccalaureate is sought and will represent at least 25% of the credit hours required for a first degree in the major. Prior to the start of the program, it is the student's responsibility to obtain a signed, approved program of study from the specific academic department for any second baccalaureate degree. In all cases, a 2.0 grade point average is required. Hours required must be related to a specific major separate from the first major. Additionally all of the hours applied to the second degree must be earned after the first degree has been awarded.

It has been suggested by others that we allow students to repeat courses, no matter what grade the student has earned. Thus, delete the statement in the policy as shown in red below. Would you please present this to Academic Council at your earliest convenience?

Listed below is what is currently in the University *Bulletin*:

# Repeating of courses taken from the 2008-2009 University Bulletin, page 67 Computation of Grade Point Averages

"Grade point averages are based on the number of hours undertaken rather than the number of hours passed in determining whether a student meets minimum standards. The total hours attempted, for suspension purposes, will include credit undertaken at the university and credit transferred; the grade point average will involve only credit for courses attempted at The University of Southern Mississippi.

Courses in which a student receives an "E" will not be counted as part of "total hours attempted" for grade point average computation. These courses will, however, be counted in determining eligibility for financial aid.

An undergraduate student will be permitted to repeat courses a total of two times or a total of six semester hours in order to improve his or her grade point average. (That is, he or she may repeat one 3 hour course twice; or two 3 hour courses once each.) The first two repeats used shall stand. The grade for the second attempt will be used in grade point average calculations. This policy is limited to courses in which a student initially earned a grade of "D" or "F," but does not apply to courses for which a grade was assigned for reasons of academic dishonesty. Courses must be retaken at The University of Southern Mississippi. Students are free to retake additional courses, but all attempts will be included in the calculation of the GPA. Exceptions to this policy must be approved by the provost. Prior to graduation, a request for an excessive repeat must be made by the student and recommended by the department and college dean before being considered by the provost. Excessive repeats will not be considered after graduation".

## DIVISION 11 PROGRAM REVIEW COMMITTEE

# **Article 1** Definition and Responsibilities and Duties

- Section 11.1.1 The Program Review Committee is a standing committee that shall be responsible for reviewing self studies for programs requiring internal review and completing the Academic Council Reviewer's Rating Form. They are also responsible for presenting the Executive Summary to the Academic Council for all programs receiving internal review, as well as presenting an Executive Summary of programs receiving external accreditation
- Section 11.1.2 In exercising its responsibility, the Program Review Committee shall perform the following duties:
  - (1) Consult with the Office of Institutional Effectiveness regarding matters related to program review.
  - (2) In September, the Program Review Committee of the Academic Council with the Office of Institutional Effectiveness will draft a memorandum for the Provost to send to those programs which are to begin the 2-year internal review process.
  - (3) At the September meeting of the Academic Council, the Program Review Committee will present a list of programs to be reported on in that academic year's Academic Council Recommendation Report.
  - (4) In May, the Program Review Committee will present the Academic Council Recommendation Report. This report will document the external accreditation activities occurring in the previous academic year. It will include an Executive Summary of all programs that have received accreditation or re-accreditation through an external accreditation agency in the previous academic year. The Executive Summaries should adhere closely to those guidelines put forth by the IHL (which are available from the Office of Institutional Effectiveness). In addition, the Academic Council Recommendation Report presented in May will include an Executive Summary of each program completing internal program review, adhering closely to those guidelines put forth by the IHL.

# Article 2 Membership

- Section 11.2.1 The Program Review Committee of the Academic Council shall consist of members representing each of the Colleges of the University and appointed by the Chair of the Academic Council from the elected representatives of the Council.
- Section 11.2.2 Members of the Program Review Committee shall serve for two years.
- Section 11.2.3 Terms of members of the Program Review Committee shall begin on the date of appointment and end with the adjournment of the organizational meeting of the Academic Council in May at the end of their terms.

Section 11.2.5 If a position on the Program Review Committee becomes vacant, the Chair of the Academic Council shall appoint an eligible replacement to serve the remainder of the term of the member replaced. An individual appointed to serve the unexpired term of a member of the Committee shall be eligible for appointment to his or her own term of membership.

## **Article 3** Officers

- Section 11.3.1 The officers of the Program Review Committee shall consist of a Chair and a Chair-Elect appointed by the Chair of the Academic Council and a Secretary if the Chair of Committee deems necessary.
- Section 11.3.2 The term of office for the Chair and the Chair-Elect shall begin on the date of appointment and end with the adjournment of the organizational meeting of the Academic Council in May.
- Section 11.3.3 If the office of Chair becomes vacant, it shall be filled by the Chair-Elect. If the office of the Chair-Elect becomes vacant, the Chair of the Academic Council shall appoint a replacement from the members of the Committee to serve the remainder of the term of the officer replaced.

## **Article 4 Duties of Officers**

- Section 11.4.1 It shall be the duty of the Chair of the Program Review Committee to preside at meetings of the Program Review Committee, assign review duties among the members of the Program Review Committee, summarize the Committee's deliberations and present recommendations, compile the Executive Summary from the individual review reports, and compile the final Academic Council Recommendation Report.
- Section 11.4.2 It shall be the duty of the Chair-Elect to assist the Chair in the execution of his or her responsibilities and to preside at meetings of the Program Review Committee in the Chair's absence.
