1. Description of the commodity that USM is seeking to procure:

Annual renewal of software support for Trimble Virtual Reference Stations /VRSNet for the GPS Infrastructure Software.

2. Explanation of why the commodity is the only one that meets the needs of the agency:

To effectively manage the state's infrastructure, GCGC must provide and maintain a common reference system on which to base and associate all research, transportation and construction related activities. The system can be used simultaneously to meet the mapping and/or navigation needs of State and Federal agencies, local municipalities, private surveyors, and the public.
