- Description of the commodity that USM is seeking to procure: Worldshare ILL is the
 platform in which Tipasa is built on. Tipasa serves as the primary software for borrowing
 and lending materials between libraries nationally. It is the next generation cloud based
 product of our current ILL software, ILLiad. It is built to incorporate our library catalog's
 published holdings for borrowing and lending.
- 2. Explanation of why the commodity is the only one that meets the needs of the agency: Tipasa incorporates the national bibliographic catalog network, WorldCat, in which we publish our libraries catalog. We utilize this catalog to promote discovery and maintain our catalog. It allows our users access to the world's largest bibliographic database, and therefore the largest resource sharing network. This extends our users research power exponentially and cannot be obtained by other products. By using Tipasa an upgraded and more efficient processing software will be available to libraries staff and users. It allows for much less hands on IT involvement for housing and administering the system.
- 3. Explanation of why the source is the only source is the only person or entity that can provide the required commodity: It is the only software built to facilitate borrowing and lending of materials using OCLC's published national bibliographic catalog, WorldCat. USM publishes our library holdings to this catalog.
