 - ARMS is developed exclusively by END2END Public Safety and meets the needs for our Communication Department with issuing report numbers, and for the officers to write complete reports and include documentation from the incident. Administration can pull reports to track activity of officers in the field as well as supporting numbers for work done by those officers.
