APPLICATION DEADLINE: FEBRUARY 1 FOR FALL; SEPTEMBER 1 FOR SPRING

Have you ever been admitted to and started attending another nursing program? \Box YES \Box NO *IFYES*, written verification of satisfactory progression in that program is required. Contact your former nursing program and request a letter to be sent to the Southern Miss College of Nursing and Health Professions verifying your status. This is a standard letter, and schools of nursing regularly send these.

Are you a Licensed Practical Nurse (LPN)? **DYES DNO** IF YES, the LPN license must be unrestricted to be eligible for admission into the BSN program.

Have you been fully admitted to Southern Miss as an undergraduate? **DYES DNO** IF NO, urgently contact Admissions to complete the process. Applicants must be accepted to The University of Southern Mississippi to be considered for admission to the Nursing program. You can contact Admissions by phone at 601.266.5000 or visit their website at usm.edu/admissions.

APPLICATION REQUIREMENTS

- 1) Applicants must have a minimum composite national ACT score of 21, earn a "C" or better in each prerequisite course and have an overall minimum prerequisite GPA of 2.5.
- 2) Three (3) of the five (5) required science courses must be completed at the time of application; this means only two (2) required science courses/lab can be UNGRADED at the time of application.
- 3) Applicants may only retake/repeat one (1) required science course one time (for which a "D" or an "F" grade was earned).
- 4) Applicants must have completed approximately 75 percent of the required prerequisites at the time of application.
- 5) Applicants must be in good academic standing (cannot be on probation, probation continued or suspension).

COMPLETED APPLICATION REQUIREMENTS

Copies of all transcripts must be attached, even Southern Miss transcripts. Written verification of minimum composite national ACT score of 21 must be attached by the applicant. This is the applicant's responsibility. The College of Nursing and Health Professions will not be responsible for obtaining transcripts/ACT scores for applicants. Even if transcripts/ACT scores have been sent to the Admissions office, students must also attach copies with the completed application to Southern Miss College of Nursing and Health Professions. Unofficial copies are acceptable. ACT information can be requested at actstudent.org. This **information should be attached and not sent separately. Students must complete the prerequisite checklist portion of the application.** All required prerequisite courses must be listed by the applicant by either entering an earned grade, semester enrolled or semester planning to enroll.

LICENSURE INFORMATION FOR APPLICANTS: Any individual having been convicted of a misdemeanor or felony may not be allowed to write the NCLEX for RN licensure. At their discretion, the Mississippi Board of Nursing has the authority to refuse licensure to anyone convicted of a misdemeanor or felony. (See State of Mississippi Laws, Rules and Regulations, Mississippi Board of Nursing Section §73-15-29 (1) (b).)

CRIMINAL BACKGROUND CHECK: Pursuant to an amendment to Mississippi House Bill HB 1077, Section §43-11-13, Mississippi Code of 1972, all applicants to the College of Nursing and Health Professions must undergo the criminal background check before beginning clinical experiences. If the student is disqualified for clinical training at an agency, the College of Nursing and Health Professions may determine that the student cannot maintain student status since clinical training is an essential part of the Nursing program.

ROUTINE ALCOHOL AND DRUG SCREENING: Every student enrolled in a clinical nursing course is required to undergo a drug screening test at least every 12 months to determine the presence of alcohol, drugs and controlled substances. If the results of the drug screening are positive for alcohol, drugs and/or other controlled substances, the student may not continue in clinical nursing courses. The student is responsible for costs associated with the drug screening and confirmation.

ADMISSION AND APPLICATION REQUIREMENTS

FOR THE SOUTHERN MISS BACHELOR OF SCIENCE IN NURSING DEGREE

- 1) Minimum national composite ACT score of 21 and minimum grade of "C" in each prerequisite course with prerequisite GPA of 2.5 are required.
- 2) Three of the FIVe required science courses must be complete at time of application.
- 3) Of the required science courses, only one natural science course may be repeated one time.
- 4) All prerequisite courses must be completed before nursing classes begin.
- 5) Students cannot be on probation, probation continued or suspension.
- 6) Fall admission deadline is February 1. Spring admission deadline is September 1. Students having completed approximately 75 percent of the prerequisite nursing courses may make application to the BSN program.
